# ANNUAL MEETING AND TOWN HALL WEDNESDAY

The meeting this Wednesday is our "Annual Meeting." It is the meeting where we take care of important Society business that occurs annually (elections, annual reports, budget, etc.) so that we can keep the business portion of the meetings in other months relative short and let us get on with the "business" we really love and get together for – growing orchids.

Elections. In even-numbered years we elect board members (in odd-numbered years, officers are elected). The nominating committee has selected the following candidates: Robert Mann, Don Steinegger, and Ron Fechner. Ron is currently a board member but he is eligible to run again since he has served less that one and ½ terms. Nominations may be made from the floor for other candidates, but the nominee must have agreed to being nominated.

### ANNUAL SHOW REPORT

The Greater Omaha Orchid Society held its twenty-seventh annual orchid show and sale on March 29 – 30, 2014. The show was held at the Lauritzen Gardens, the location for the preceding six shows. Attendance at the show was 2,466 people with 1,239 holding Garden memberships. Coupons for \$5.00 admission were used by 370 of the attendees (in addition to the post-cards, these included email coupons and Omaha World Herald ad coupons). The postcards were distributed by garden staff, volunteers, and GOOS members.

There were 13 exhibitors at the show, including exhibits by five orchid societies (Lincoln Orchid Society, Meeting of Orchid Friends, Orchid Society of Greater Kansas City, Central Iowa Orchid Society, and Greater Omaha Orchid Society). Two GOOS members had their own display: Marilyn Hawes and Twilla Westercamp. Vendors at the show were Bird's Botanicals (Blue Springs, MO), Iowa Orchids (Des Moines, IA), Natt's Orchids (Naperville, IL), Orchid Inn, Ltd (Bloomington, IL), Orchids Garden Centre & Nursery/Oak Hill Gardens (Waunakee, WI), New Earth Orchids, Santa Fe, NM, Paradigm Gardens (Omaha, NE) and The Plant House (Omaha, NE). We had American Orchid Society judges from the Mid-America (St. Louis, MO), Great Plains (Oklahoma, OK) and Rocky Mountain (Denver, CO) Judging Centers.

The AOS Show trophy was awarded to the Orchid Society of Greater Kansas City. Beyond these special award were numerous first, second, and third place ribbons as well as rosettes and Best of Class trophies. There were also ten American Orchid Society awards (including the AOS Show trophy).

Financial data for the show is in the Treasurer's Report.

Next year's show is scheduled for March 7 - 8, 2015 at the Lauritzen Gardens. Many members worked long and hard during setting up the show and during the course of the show. The success of the 2014 show is a result of the efforts of all members who participated. Thank you. *Jim Pyrzynski, Show Chair* 

# 2013-2014 Treasurer's Report

I took over the accounting starting on September 1st 2013. The actual balancing of the ledger, statements, and checkbook are correct to the best of my knowledge and tie back to the bank account with the exception of 4 outstanding checks. One of which was mailed to the church where we had our meeting in June and the other 3 where just sent out to: AOS for 2015 show registration, Mid-America and Great Plains Judging centers for our yearly donations. The categories of the expenses and income of the Society was continued from the previous year to the best of my knowledge. I may have categorized some items differently then my predecessor, but tried to match up the existing buckets as best as possible. The E-postcard for Federal Tax Filing was submitted on 1/18/2014. The state taxable year is based on the Jan. to Dec. 2013 Year. Net Taxable sales were \$3,991. Total Nebraska and local sales and use tax paid was \$199.62. The picnic and auction this year was little chaotic since it was my first year so I was a little disorganized but we raised more money than previous years, after the expenses for plants bought for the auction we took in \$1,945. Hopefully next year now that I know the expectation it will move more smoothly, we will see. The new fiscal year began on September 1, 2014 and will run to August 31 2015.

#### REPORTS

Greater Omaha Orchid Society General Meeting August 13, Douglas/Sarpy County Extension Office

The August meeting was the annual picnic/potluck and auction. President Eric Stoiber called the meeting to order for dinner at 6:30 PM. He thanked everyone for coming and listed the donors and sources of the plants for auction: Donors: H & R Nursery (Roy Tokunaga), Windy Hill (Marilyn LeDoux), Miranda Orchids (Francisco Miranda), Sunset Valley Orchids (Fred Clarke), Max Thompson and Bryon Rinke; purchased plants from Carmela Orchids. There were some additional member donated plants. Eric also discussed the Eastern Iowa Orchid Society show which will be held in Cedar Rapids in mid October, GOOS will have a display and plants will be needed. The Auction began at 7:30 with Dave Taylor as auctioneer.

08-27-2014 Greater Omaha Orchid Society Meeting of the Board of Directors Sump Memorial Library, Papillion, NE.

Present: President Eric Stoiber, Vice President Jim Pryzynski, Treasurer Aaron Bugjo, Past President Roberta Ginavan, Jackie Lewzader, Ron Fechner, and Marie Smith.

President Stoiber called the meeting to order at 7:00 p.m. with review of the prepared GOOS 2013 - 2014 Financial Report of Revenues and Expenses prepared by Treasurer Aaron Bugjo.

Year to Date Net Profit is \$1,677.67 to carry over for expenses after year's expenses of \$5,794.23. Federally Declared Fiscal Year is September 1 to August 31st.

Line by line review occurred starting with membership dues. New revisions included dues, revised to \$600 projected. Roberta has a box of ORCHID magazines. Board suggested giving one magazine per new membership.

Members discussed categorical labels for the accounting ledger, recommending changes that would clarify the intent of line items, such as plant resales vs. plant purchases.

Memorial donations and designated vs. undesignated funds were discussed. Other ways to categorize the Dr. Skultety Memorial Award may be discussed in the future. Year by year, a small amount of this fund is used for an orchid award.

Affiliations: treasurer noted that a 2-year subscription this year raised the expense. However, next year, there will be no cost. New purchases for sales were enthusiastically endorsed for the coming year, as none were made during the past year. Safe Deposit Box signature forms needs to be updated for access.

The Judging Center Donation of \$250 and the webmaster fee are the only costs to be added for finalization. The board completed the review with compliments to Treasurer Aaron Bugjo and accepted the revisions for the upcoming fiscal year. Jackie Lewzader will transport the accounting books to the Audit Committee in preparation for review and ledger and report.

President Stoiber introduced topic of speakers and wishes to learn the views of members. "How to reach out to the community" was discussed. Vice President Pryzynski suggested volunteering for the new conservatory and other functions at Lauritzen Gardens. He also made the board aware of an orchid blooming at Fontenelle Forest. He informed Marge From, Director of Plant Conservation at the Henry Doorly Zoo, about the orchid. Marge From has drafted a grant proposal for a study of the orchid which would involve UNO personnel and students and the orchid society. Thiis could be an additional source for mew members. Aaron Bugjo suggested opening the speakers presentations to the public, in hopes of increasing visibility for GOOS. Members - free; \$2-\$5 for non-members. Roberta added possibility of a "Speakers Day." Jacque suggested a plant sale. Ron added idea of a sponsor. Drawing upon new members and younger members to jump in was noted. Marie suggested presentations at grocery stores, where orchids are sold and attaching GOOS business cards to each orchid sold. Jacqueline noted a past opportunity at Whole Foods. Natural Foods has a special "classroom space" yet does not have orchids...

Discussion will continue on ideas. GOOS needs new members to step up into positions and discussions.

Meeting adjourned at 9:00 p.m.
